1.5 Test Conditions:

The object probe with diameter of $1.0^{+0.05}_0$ mm pushed against any openings of the enclosure with the force of $1N \pm 0.1N$.

The sample was put into a test chamber with 2kg talc per cubic meter to start the test. During the test, the sample was kept in a vacuum state, the maximum pressure difference was 2kPa, and the pumping speed was lower than 40 times the shell volume per hour, and the test was carried out for 8 hours.

1.6 Judge Criteria: The test probe should not pass through any opening, and no dust should be allowed inside the sample after testing.


